The Boyne City Farmers Market Mission Statement

Boyne City Farmers Market Code of Conduct

The primary purpose of this Code of Conduct is to ensure the wellbeing of all participants. Vendors are expected to behave courteously to customers, other vendors, and market staff. It is the market's intent to serve the public and create a friendly atmosphere that will benefit both the vendors and customers.

As a Boyne City Farmers' Market vendor and/or their representative, I will:

- Respect and adhere to all rules established by the Boyne City Farmers' Market and Market at the Pavilion
- Not willingly deceive or exploit customers or the Market Manager concerning Market business.
- Demonstrate the highest standards of personal behavior and integrity at all times.
- Treat everyone with respect. Rude, violent, aggressive, uncooperative or belligerent behavior toward others will not be tolerated.
- Under no circumstance, attend or participate in the Boyne City Market at the Pavilion while under the influence of alcohol and/or controlled substance.

It is important that all Boyne City Market at the Pavilion vendors and/or their representatives comply with the Code of Conduct. Failure to comply with any component of the code or participation in other inappropriate conduct as determined by the Market Manager or market executive committee may lead to dismissal as a vendor at the Boyne City Market at the Pavilion.
